**Art. 1 - Call for applications**

(b) applications are invited for the selection of maximum 5 students enrolled in the MSc in Economics and Development (curriculum in Economics) of the University of Florence for mobility at the Faculty of Social Sciences, Economics and Business Administration of the Otto Friedrich University of Bamberg in the period October 2026 – July 2027;



(c) applications are invited for the selection of maximum 5 students enrolled in the MSc in Economics and Development (curriculum in Economics) of the University of Florence for mobility at the Faculty of Economic Sciences of the University of Rennes in the period September 2026 - June 2027.

### **Art. 2 – Purpose of the Mobility**

(a) 1. The purpose of the mobility at the Faculty of Business and Economics of the Georg August University of Göttingen is

- (i) to attend the compulsory and optional courses indicated in the study plan in Addendum 2 (for students with home university the University of Florence) to the Agreement between the University of Florence and the Georg August University of Göttingen establishing the Double Degree Program, available [here](#);
- (ii) to take the exams at the end of the aforementioned courses.

2. The students participating in the Double Degree Program will write their master thesis at the Georg August University of Göttingen at the end of the second year.

3. The degrees by the two universities, MSc in Economics and Development of the University of Florence, and MSc in Development Economics of the Georg August University of Göttingen, will be awarded when each partner university certifies that the student has completed the cycle of studies according to the study plan and has successfully completed his/her master thesis.

(b) 1. The purpose of the mobility at the Faculty of Social Sciences, Economics and Business Administration of the Otto Friedrich University of Bamberg is

- (i) to attend the compulsory and optional courses indicated in the study plan in Appendix 1.3 to the Implementing Agreement between the University of Florence and the Otto Friedrich University of Bamberg establishing the Double Degree Program, available [here](#);
- (ii) to take the exams at the end of the aforementioned courses.

2. The students participating in the Double Degree Program will write their master thesis at the Otto Friedrich University of Bamberg at the end of the second year.

3. The degrees by the two universities, MSc in Economics and Development of the University of Florence, and MSc in European Economic Studies of the Otto Friedrich University of Bamberg, will be awarded when each partner university certifies that the student has completed the cycle of studies according to the study plan and has successfully completed his/her master thesis.

(c) 1. The purpose of the mobility at the Faculty of Economic Sciences of the University of Rennes is:

- (i) to attend the courses indicated in the study plan in Annex 1 (for students with home university the University of Florence) to the Cooperation Agreement between the University of Florence and the University of Rennes establishing the Double Degree Program, available [here](#);
- (ii) to take the exams at the end of the aforementioned courses.

2. The students participating in the Double Degree Program will write their master thesis at the University of Rennes at the end of the second year.

3. The degrees by the two universities, MSc in Economics and Development of the University of Florence, and International Master in Public Policies of the University of Rennes, will be awarded when each partner university certifies that the student has completed the cycle of studies according to the study plan and has successfully completed his/her master thesis.



### Art. 3 - Admission Requirements

(a) The students who may apply for mobility at the Faculty of Business and Economics of the Georg August University of Göttingen are the students who are regularly enrolled, by the deadline of the present call (see Art. 4), for the academic year 2025/2026 in the first year of the MSc in Economics and Development (curriculum in Development Economics) and moreover:

1. have a certified knowledge of the English language at C1 level;
2. have earned, before enrolling in the MSc in Economics and Development, at least 60 ECTS in the following areas: economics (microeconomics, macroeconomics, economic policy, public economics, applied economics), mathematics, statistics, econometrics, agricultural economics, economic geography, economic history, history of economic thought, and at least 12 additional ECTS in the following areas: mathematics, statistics, econometrics;
3. have an average grade at the exams of the courses Development Microeconomics, Statistical Inference of the MSc in Economics and Development not lower than 26/30.

(b) The students who may apply for mobility at the Faculty of Social Sciences, Economics and Business Administration of the Otto Friedrich University of Bamberg are the students who are regularly enrolled, by the deadline of the present call (see Art. 4), for the academic year 2025/2026 in the first year of the MSc in Economics and Development (curriculum in Economics);

(c) The students who may apply for mobility at the Faculty of Economic Science of the University of Rennes are the students who are regularly enrolled, by the deadline of the present call (see Art. 4), for the academic year 2025/2026 in the first year of the MSc in Economics and Development (curriculum in Economics)

### Art. 4 - Application

- The list of the exams, with grades, which the applicant has passed (including the exams taken and awaiting the grade) in the MSc of Science in Economics and Development;
- The list of the exams, with grades, which the applicant has passed at university level before enrolling in the MSc in Economics and Development;
- The final grade of the Bachelor's degree;
- A certification of English language proficiency at C1 level only for applications for mobility at the Faculty of Business and Economics of the Georg August University of Göttingen;
- A curriculum vitae;
- A motivation letter for the mobility;
- Any other documents deemed useful by the applicant for the purpose of this selection - for example, certification of knowledge of the German language for mobility at the Faculty of Business and Economics of the Georg August University of Göttingen or at Faculty of Social Sciences, Economics and Business Administration of the Otto Friedrich University of Bamberg, certification of knowledge of the



French language for mobility at the Faculty of Economic Science of the University of Rennes.

2. Applications for mobility at the Faculty of Business and Economics of the Georg August University of Göttingen must be completed using Annex A1 to this selection notice (pages 8-10).

Applications for mobility at the Faculty of Social Sciences, Economics and Business Administration of the Otto Friedrich University of Bamberg or for mobility at the Faculty of Economic Science of the University of Rennes must be completed using Annex A2 to this selection notice (pages 11-13). A first-year student of the curriculum in Economics may apply for mobility at both Universities, but if selected for both mobilities then will have to choose only one among the two alternatives.

#### **Art. 5 – Selection Committee**

The Selection Committee will be nominated by the Dean of the School of Economics and Management after the deadline of the present call (see Art. 4) and will be published on the School's web page, [www.economia.unifi.it](http://www.economia.unifi.it). The Selection Committee will meet on February 24, 2026, at 2.30p.m. to determine the ranking of the applicants.

#### **Art. 6 – Ranking of the applicants**

(a) The ranking of the applicants for mobility at the Faculty of Business and Economics of the Georg August University of Göttingen will be determined on the basis of the following criteria:

- (i) Final grade of the Bachelor's degree;
- (ii) Motivation letter;
- (iii) Average grade at the exams of the courses Development Microeconomics, Statistical Inference of the MSc in Economics and Development.

If two or more applicants are tied on the basis of the aforementioned criteria, then certified knowledge of the German language and the ECTS-weighted averages of the grades at the other exams of the MSc in Economics and Development passed by the applicants are considered.

The first five applicants in the ranking will be admitted to the mobility. The ranking will be published by a decree of the Dean of the School on the official register of the University of Florence, <http://www.unifi.it/albo-ufficiale.html>, and on the website of the School of Economics and Management.

### **Art. 7 – Acceptance of the mobility**

The selected students will have to formalize their acceptance of the mobility before departure by signing a specific form that will be available at the International Relations Office of the School of Economics and Management. Students who do not sign this acceptance form will be excluded without further notice.

### **Art. 8 – Financial support for the mobility**

Each student participating in the Double Degree Program will be awarded an Erasmus+ scholarship.

### **Art. 9 – Processing of personal data**

The personal data transmitted by the applicants during the application procedure will be processed for the purpose of managing the selection process in accordance with the University Regulations for the implementation of the Code of Protection of personal data held by the University of Florence, issued by decree of the Rector N. 449 (Prot.
