


MSc main features

Interdisciplinary skills (II)

- > Students acquire a diversified spectrum of skills
- ➤ Key competences: solid economic knowledge, problem-solving skills, analytical thinking, and economic intuition.
- Students are provided with tools
 - ✓ to analyse and possibly solve socio-economic problems within international organisations, companies or governments,
 - ✓ to collect, analyze and interpret quantitative and qualitative information from local, national and international datasets,
 - ✓ to use economic and econometric methods to formulate and evaluate global and sectoral economic policies by learning software as Phyton, Stata, etc.
 - ✓ to conduct research in the field of economic development or economics.
- ➤ A sound background in economics and quantitative methods is matched with an **interdisciplinary approach** (legal, business, finance, historic, etc.) to develop additional useful skills for the job market

Curriculum in Development Economics

For students interested in understanding the economies of less developed countries, why some countries managed to grow, and reduce poverty and others did not, the drivers of successful economic development and the causes for stagnation, the design and evaluation of policies that promote sustainable/inclusive growth, education for all, global health, food security and reduce income inequality, gender inequality, conflict, etc.

Curriculum in Development Economics: Career opportunities

It provides an ideal background for work as a professional development economist in national and international agencies, civil service appointments, Non-Governmental Organizations (NGOs) and private sector companies with interests in developing countries or for pursuing a PhD programme (in Development Economics and related topics) at leading universities around the world.

Curriculum in Economics

For students interested in acquiring skills for a successful career as professional economist, in learning quantitative tools to analyse major current economic issues and policies, in using theoretical and empirical techniques to analyse the competitiveness of markets, to forecast macroeconomic and financial variables, to evaluate programs for private and public institutions.

Track in Economics for students interested in using economics and econometric methods to analyze data and formulate or evaluate global and sectorial economic policies, and in conducting theoretical and applied research in economics.

Track in Behavioral Economics for students interested in theoretical and experimental analysis of individual behaviors and institutions, taking into account the effects of psychological, cognitive, emotional, cultural and social factors.

Curriculum in Economics: Career opportunities

Both tracks provide an ideal background for work as a professional economist in a wide range of positions in private economic consultancy agencies, business, finance, central banking, national and international organisations and governments or for pursuing a PhD programme (in Economics and related topics) at leading universities around the world.

Admission (I)

Curricular requirements:

- 18 CFU in Economics (*SECS-P/01-P/02-P/03*)
- 6 CFU in Statistics (S/01 or SECS P/05)
- 6 CFU in Mathematics (S/06 or MAT/01-09)
- English level B2 (Common European Framework of Reference for Languages).

Note:

- Missing basic knowledge can also be acquired by enrolling in single courses, indicated by the Teaching Committee.
- Graduate students with a bachelor degree in Economics (*Economia e Commercio*), in *SECI*, or Management (*Economia Aziendale*) satisfy the curricular requirements.

Admission (II)

- Bachelor Degree grade not smaller than 99 out of 110
- Candidates whose Bachelor degree grade is lower than 99 out of 110 are asked to sit an **interview** (or a test).

The Teaching Committee may also take into account the candidate's **curriculum vitae**.

The **syllabus** for the interview (or the test) is made available in advance.



- ➤ 60 CFU in Economics / Mathematics / Statistics / Econometrics / Agricultural Economics / Economic Geography / Economic History

Selection criteria

- Bachelor degree grade
- Motivation letter

- Average grade of the compulsory exams taken in the first semester of the first year
- In case of a tie, there will be taken into account:
 - knowledge of German language (only if certified)
 - weighted average of the non-compulsory exams of the first semester of the first year






