It will be an opportunity for teachers to give visiting lectures at our university under the Erasmus Teaching & Staff Mobility Programme.

Academics are welcome to propose lectures in a variety of topics (<u>please check the application form for a complete list of available topics</u>). The lectures are targeted at Master students. The teaching language is either English or Italian.


We will analyze the content of each proposal and confirm if we can find a receiving lecturer on our side.

There is no participation fee. However, participants should cover the cost of travel, accommodation and meals. Where applicable, the funding might be available from the Erasmus grant distributed by the **home university**. We invite candidates to check the availability of such funding with their home institution. Please note that the Erasmus+ programme requires visiting lecturers **from partner universities** to give at least 8 hours of lectures within the regular courses offered by the host university, some of which might be given under the form of research seminars.

Please note that you are required to indicate the course(s) – among those listed in the application form – that best match(es) your lecture(s).
