- HAVING REGARD to the agreement stipulated on 13/06/2024 between the University of Florence and École Supérieure de Commerce d'Amiens for the establishment of a shared training course within the Bachelor Degree Course in Sustainable Business For Societal Challenges at the University of Florence and the Bachelor Degree In Management And Marketing, Specialisation International Business at the École Supérieure de Commerce d'Amiens, aimed at issuing qualifications from both universities;
- CONSIDERING that the University has the responsibility (art.12 letter f of law 390/91) to promote student exchanges;
- HAVING REGARD to the "Guidelines to be adopted by educational structures on the subject of recognition of the educational activity carried out by students in the context of the mobility envisaged by the Socrates/Erasmus programme" approved by the Academic Senate in the session of 3 December 2003 and, in particular, the art. 10 which provides that these provisions may also apply in the event that student mobility takes place in the framework of any other EU inter-university mobility program or any international cooperation agreement;
- HAVING REGARD to the Statute of the University of Florence and, in particular, the art. 9;
- HAVING REGARD to the University Teaching Regulations and, in particular, the articles. 11 and 12;

DECREES

the issuing of the following Notice:

Art. 1 - Call for applications

Applications are invited for the selection of a maximum of 5 students enrolled in the degree course Sustainable Business for Societal Challenges of the University of Florence (Italy), for mobility at the École Supérieure de Commerce d'Amiens (France) in the period September 2026 - July 2027.

Art. 2 – Purpose of the Mobility

1. The purpose of the mobility is:
 - a) to attend the compulsory and optional courses indicated in the study plan in Addendum 2 of the Convention
 - b) to sit the exams and tests at the end of the courses indicated in the study plan in Addendum 2 of the Convention.
2. The students participating in the program will write their final thesis at the École Supérieure de Commerce d'Amiens at the end of the third year.
3. The degree by both universities (bachelor's degree in Sustainable Business for Societal Challenges of the University of Florence and bachelor's degree in Management and Marketing, specialization International Business of the École Supérieure de Commerce d'Amiens) will be awarded when each partner university certifies that the student has completed the cycle of studies according to the study plan and has successfully completed his/her thesis.

Art. 3 - Admission Requirements

Students who, by the deadline of the present call, are regularly enrolled for the academic year 2025/2026 in the second year of the bachelor's degree in Sustainable Business for Societal Challenges of the University of Florence may apply if they:

- a) have taken all the first-year exams and all the first-semester second year exams;
- b) have not participated in previous Erasmus mobility programs while enrolled in the SUSBUS study program.

Art. 4 – Application

1. In the application, to be addressed to the Dean of the School of Economics and Management, the candidate must declare, under his/her own personal responsibility, according to the decree of the President of the Republic No. 445/2000, the following:
 - surname and name
 - date and place of birth
 - postal address and institutional e-mail address
 - a declaration of successful completion of the first-year exams and the first semester of the second-year exams
 - a copy of a valid identity document
 - a letter of motivation for the mobility
 - any certification of knowledge of the French language (if available)
2. Applications must be completed according to the appropriate form attached to this selection notice and sent online using the application at the following address <https://sol.unifi.it/postlauream/login.jsp>
3. Applications must be received no later than the 22nd of February 2026 at 13:00, under penalty of exclusion.



4. The Administration has the right to carry out appropriate checks on the truthfulness of the declaration and certifications contained in the application.

Art. 5 – Selection Committee

The Selection Committee will be nominated by the Dean of the School the day after the deadline of this Call and will be published on the School's web page (www.economia.unifi.it). The Selection Committee will meet on February 25 to determine a ranking of the candidates.

Art. 6 – Ranking

The ranking will be established based on the following criteria:

- average grade of the exams of the first year and the first semester of the second year of the Bachelor Degree in Sustainable Business for Societal Challenges
- certified knowledge of French language
- letter of motivation

The first five candidates in the ranking will be admitted to the mobility. The ranking will be published by a decree of the Dean of the School on the official register of the University of Florence, <http://www.unifi.it/albo-ufficiale.html>, and on the website of the School of Economics and Management.

Art. 7 – Acceptance of the mobility

The selected students will have to formalize their acceptance of the mobility by signing a specific form that will be sent by the International Relations Office of the School of Economics and Management; students who do not sign this acceptance form will be excluded without further notice.

Art. 8 – Financial support

Each student participating in the Double Degree will be awarded an Erasmus+ scholarship.

Art. 9 – Processing of personal data

The personal data transmitted by the candidates during the application procedure will be processed for the purpose of managing the selection process in accordance with the University Regulations for the implementation of the Code of Protection of personal data held by the University of Florence, issued by decree of the Rector N. 449 (Prot. No 33210) of 7 July 2004 and subsequent amendments. At any time, the parties involved may exercise their rights under that regulation.
